**BAC RESOLUTION RECOMMENDING AWARD FOR THE
PROCUREMENT OF VARIOUS DRUGS AND BIOLOGICS – (A38)**

**Resolution No. OrU-2022
Series of 2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 5, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Drugs and Biologics – Short of Award under the SAAD Program-NEP 2022 with a total Approved Budget for the Contract (ABC) of **One Million One Hundred Fifty-Two Thousand Three Hundred Thirty Pesos (P1,152,330.00)** and grouped into Six (6) Lots:

Lot 1 – Vaccines	101,500.00
Lot 2 – Vitamins	392,100.00
Lot 3 – Antibiotics	407,180.00
Lot 4 – Ectoparasiticide	550.00
Lot 5 – Dewormer	241,400.00
Lot 6 – Wound Spray	9,600.00

WHEREAS, an opening of bids was conducted on November 29, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled and the BAC declared the lone bid of P & J Agricultural Trading Inc. as “passed” during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on December 10, 2021, the BAC determined that the bid submitted by P & J Agricultural Trading Inc. for Lots 2,3,4,5&6 as a Single Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on January 11, 2022, a virtual post qualification, via meet.google.com/bms-yizt-czd, to P & J Agricultural Trading Inc. for Lots 2, 3, 4, 5 & 6, being the Single Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on January 17, 2022, it was found out that P & J Agricultural Trading Inc. had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of drugs and biologics for Lots 2, 3, 4, 5 & 6 to P & J Agricultural Trading Inc. as its bid was considered the Single Calculated and Responsive Bid;
