**RESOLUTION RECOMMENDING THE PROCUREMENT OF 1,550 BAGS OF HYBRID RICE SEEDS  
THRU NEGOTIATED PROCUREMENT-EMERGENCY PURCHASES**

Resolution No. 035-2022  
Series of 2022

WHEREAS, the Department of Agriculture-Regional Office Caraga intends to purchase 1,550 bags of Hybrid Rice Seeds through the Rice Program with an ABC of Seven Million Seven Hundred Fifty Thousand Pesos (P 7,750,000.00) under the Quick Response Fund (QRF) grouped as follows;

- Lot 1- 250 bag Hybrid Rice Seeds M83
- Lot 2- 550 bag Hybrid Rice Seeds M80
- Lot 3- 250 bag Hybrid Rice Seeds M46
- Lot 4- 250 bag Hybrid Rice Seeds M82
- Lot 5- 250 bag Hybrid Rice Seeds M97

WHEREAS, the said production inputs are aimed to help the farmers to recover from the devastated effects of Typhoon Odette and enable them to rehabilitate their farms as soon as possible;

WHEREAS, there is a need to procure these inputs the soonest time possible to provide immediate response to the affected farmers for them to replant and regain their farm losses;

WHEREAS, Section 53.2 of the latest *Implementing Rules and Regulations of RA 9184* provides for the Negotiated Procurement-Emergency Cases maybe resorted to in cases of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary;

WHEREAS, the DA issued a memorandum dated February 3, 2022 to resort to Negotiated Procurement-Emergency Cases to expedite the procurement of various goods as immediate response to the farmers affected by Typhoon Odette and help them recover from their present state;

WHEREAS, the BAC conducted the procurement activities using the Negotiated Procurement-Emergency Cases to fast track the procurement process;


WHEREAS, the BAC determined the suppliers who are legally, technically, and financially capable based on records and conducted post qualification to determine the supplier's capacity to supply the requirements of this office;

WHEREAS, there were four (4) bidders that submitted its quotation, namely, Right AgriDev, Inc, Longping Tropical Rice Devt, Inc, Jedeco Trading Corporation and SL Agritech Corporation per Abstract of Quotations;

WHEREAS, upon final deliberation conducted by the BAC members on March 7, 2022, it was found out that Right AgriDev, Inc, Longping Tropical Rice Devt, Inc, Jedeco Trading Corporation and SL Agritech Corporation had passed the post qualification requirements and was considered responsive to the terms and conditions set;

NOW THEREFORE, in order to promote economy and efficiency, the Bids and Awards Committee of this office hereby recommend to the Head of Procuring Entity, Engr. Ricardo M. Oñate, Jr. to award the procurement of L1 to Right AgriDev, Inc, Lot 2- Longping Tropical Rice Devt, Inc, Lot 3-4 -Jedeco Trading Corporation and Lot5 - SL Agritech Corporation for having a single calculated and responsive quotation;




