WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 5, 2021 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 3 units Farm Tractor - Short of Award under the Corn Program-GAA 2022 with a total Approved Budget for the Contract (ABC) of **Nine Million Pesos (P 9,000,000.00)**;

WHEREAS, an opening of bids was conducted on November 29, 2021, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled thru blended mode using the link: [meet.google.com/myv-ameh-caz](https://meet.google.com/myv-ameh-caz) and the BAC declared the bids of Fortunetract Agro Sales, Inc, Ford Tractor Philippines Inc, Powerarc Industrial Machinery Corporation, PI Farm Products Inc. and Filholland Corporation as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on December 10, 2021, the BAC determined that the bid submitted by Ford Tractor Philippines Inc., as the Lowest Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on January 13, 2022, an **onsite** post qualification to Ford Tractor Philippines Inc, being the Lowest Calculated Bid to determine the authenticity of the submitted documents and its **capability** to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on March 7, 2022, it was found out that Ford Tractor Philippines Inc, had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the procurement of 3 units Farm Tractor to Ford Tractor Philippines Inc, as its bid was considered the Lowest Calculated and Responsive Bid.
