**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF  
INBRED RICE SEEDS (B10)**

**Resolution No. 079-2022  
Series of 2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last February 11, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Inbred Rice Seeds under the Rice Program-GAA 2022 with a total Approved Budget for the Contract (ABC) of **Twelve Million Four Hundred Nineteen Thousand Nine Hundred Twenty Pesos (P 12,419,920.00)** grouped into two (2) lots;

<b>Lot 1 - 3,096 bags Inbred Rice Seeds -</b>	<b>2,352,960.00</b>
<b>Lot 2 - 13,246 bags Inbred Rice Seeds -</b>	<b>10,066,960.00</b>

WHEREAS, an opening of bids was conducted on March 7, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and the BAC declared the lone bid of Bayugan Seeds Center as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on March 11, 2022, the BAC determined that the bid submitted by Bayugan Seeds Center as the Single Calculated Bid for Lot 1 and Lot 2 and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on March 15, 2022, a virtual post qualification, via [meet.google.com/bdd-ewqv-yak](https://meet.google.com/bdd-ewqv-yak), to Bayugan Seeds Center being the Single Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on March 18, 2022, it was found out that Bayugan Seeds Center had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of Lot 1 - 3,096 bags Inbred Rice Seeds and Lot 2 - 13,246 bags Inbred Rice Seeds to Bayugan Seeds Center as its bid was considered the Single Calculated and Responsive Bid;


