**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF
1 UNIT HAULING TRUCK (B3/A14)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last February 11, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of One (1) unit Hauling Truck under Corn Program-GAA 2022 with a total Approved Budget for the Contract (ABC) of **One Million Nine Hundred Eighty Thousand Pesos (₱1,980,000.00)**.

WHEREAS, an opening of bids was conducted on March 7, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and the BAC declared the bids of Hyundai Cebu, Inc., Hyundai Southern Mindanao, Inc., and The legacy Trucks and Tractors Inc. as "passed" during the preliminary examination of bids;

WHEREAS, upon deliberation of the detailed bid evaluation conducted on March 11, 2022, the BAC determined that the bid submitted by Hyundai Cebu, Inc. as the Lowest Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted on March 15, 2022, a virtual post qualification, via meet.google.com/bdd-ewqv-yak, to Hyundai Cebu, Inc. being the Lowest Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on March 18, 2022, it was found out that Hyundai Cebu, Inc., had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;



RESOLVED, this 18th day of March 2022 at Butuan City, Philippines.




