RESOLUTION RECOMMENDING THE PROCUREMENT AND AWARD OF 3500 BAGS OF COMPLETE FERTILIZER THRU NEGOTIATED PROCUREMENT-EMERGENCY PURCHASES

Resolution No. <u>090 - 2022</u> Series of 2022

WHEREAS, the Department of Agriculture-Regional Office Caraga intends to purchase 3500 bags of Complete Fertilizer with Multi Nutrient through the Rice Program with an ABC of Six Million Three Hundred Thousand Pesos (P 6,300,000.00) under the Quick Response Fund (QRF);

WHEREAS, the said production inputs are aimed to help the farmers to recover from the devastated effects of Typhoon Odette and enable them to rehabilitate their farms as soon as possible;

WHEREAS, Section 53.2 of the latest Implementing Rules and Regulations of RA 9184 provides for the Negotiated Procurement-Emergency Cases maybe resorted to in cases of imminent danger to life or property during a state of calamity, or when time is of the essence arising from natural or man-made calamities or other causes where immediate action is necessary;

WHEREAS, the DA issued a memorandum to expedite the procurement of various goods as immediate response to the farmers affected by Typhoon Odette and help them recover from their present state;

WHEREAS, the BAC conducted the procurement activities using the Negotiated Procurement-Emergency Cases to fast tract the procurement process and awarded to BACPHIL Planters Fertilizer, Corp, however said supplier waived to supply the items due to price escalation in the market;

WHEREAS, the BAC determined other suppliers who are legally, technically, and financially capable based on records and conducted post qualification to determine the supplier's capacity to supply the requirements of this office;

WHEREAS, there were two (2) bidders that submitted its quotation, namely Modern Time Enterprises, Inc., and Jeel's Masagana Farm Supply per Abstract of Quotations;

WHEREAS, upon final deliberation conducted by the BAC members on April 11, 2022, it was found out that Modern Time Enterprises, Inc., having the lowest calculated quotation had passed the post qualification requirements and was considered responsive to the required technical specifications as well as to the terms and conditions;

NOW THEREFORE, to promote economy and efficiency, the Bids and Awards Committee of this office hereby recommend to the Head of Procuring Entity, Engr. Ricardo M. Oňate, Jr. to award the procurement of 3,500 bags of quotation;
