**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 350 BAGS  
HYBRID RICE SEEDS (M50) (C3)**

**Resolution No. 271-2022  
Series of 2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 25, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the procurement of 350 bags Hybrid Rice Seeds (M50) under Rice Program-GAA 2022 with a total Approved Budget for the Contract (ABC) of **One Million Seven Hundred Fifty Thousand Pesos (P 1,750,000.00)**;

WHEREAS, a pre-bid conference was held virtually through <https://meet.google.com/yih-ztes-gtx> last, April 4, 2022 as scheduled;

WHEREAS, an opening of bids was conducted on April 19, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there was only one (1) bid received from Right Agri Development Incorporated;

WHEREAS, upon opening of the bids, the BAC members examined the submitted technical and financial component of its bid to verify the presence or absence of the required documents and bid of Right Agri Development Incorporated was rated as "Passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by Right Agri Development Incorporated as a Single Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on April 28, 2022 the post qualification to Right Agri Development Incorporated, having the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 4, 2022, it was declared that Right Agri Development Incorporated had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of 350 bags Hybrid Rice Seeds (M50) to Right Agri Development Incorporated as its bid was considered the Single Calculated and Responsive Bid;
