**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 253 BAGS HYBRID CORN SEEDS (D10)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last May 17, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 253 bags Hybrid Corn Seeds under Corn Program-GAA 2022 with a total Approved Budget for the Contract (ABC) of **One Million Five Hundred Eighteen Thousand Pesos (P 1,518,000.00)**;

WHEREAS, an opening of bids was conducted on June 7, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and the BAC declared the lone bid of Jedeco Trading Corp as "passed" during the preliminary examination of bids;

WHEREAS, upon preliminary deliberation of the detailed bid evaluation results conducted on June 13, 2022, the BAC determined that the bid submitted by Jedeco Trading Corp. as a Single Calculated Bid and qualified to undergo post qualification;

WHEREAS, the BAC together with the TWG conducted a post qualification, to Jedeco Trading Corp. being a Single Calculated Bid to determine the authenticity of the submitted documents and its capability to supply the contract;

WHEREAS, upon final deliberation conducted by the BAC members on June 27, 2022, it was found out that Jedeco Trading Corp had passed the post qualification requirements and was considered a Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of 253 bags Hybrid Corn Seeds to Jedeco Trading Corp as its bid was considered a Single Calculated and Responsive Bid;


