**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF
1 UNIT FARM TRACTOR (C7)**

**Resolution No. 296-2022
Series of 2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 25, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the procurement of 1-unit Farm Tractor under 4Ks Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of **Two Million Pesos (P 2,000,000.00)**;

WHEREAS, an opening of bids was conducted on April 19, 2022, 9:00 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there was only one (1) bidder who submitted its bid, namely, Agri Component Corporation;

WHEREAS, upon opening of the bids, the BAC members examined the submitted technical and financial component of its bid to verify the presence or absence of the required documents and it was rated as "passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by Agri Component Corporation as a Single Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification to Agri Component Corporation having the Lowest Calculated Bid to determine its capability to deliver the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 4, 2022, it was declared that Agri Component Corporation had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply of 1-unit Farm Tractor to Agri Component Corporation as its bid was considered a Single Calculated and Responsive Bid;
