**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF THREE (3) UNITS
COMPACT RICE MILL (C5/D13) THROUGH NEGOTIATED PROCUREMENT DUE TO 2-FAILED BIDS**

WHEREAS, the Department of Agriculture Regional- Caraga intends to procure 3 units Compact Rice Mill under the Rice Program-GAA 2021 with a total Approved Budget for the Contract (ABC) of **One Million Two Hundred Ninety Nine Thousand Nine Hundred Ninety Pesos (₱ 1,299,990.00)**.

WHEREAS, there had been two failed biddings declared by the BAC due to no bids received during the opening of bids scheduled on April 19, 2022 and June 7, 2022;

WHEREAS, Sec. 53.1 of the Revised IRR, provides for the Negotiated Procurement in case of **Two Failed Biddings**, where the Procuring Entity can directly negotiate a contract with a technically, legally and financially capable supplier, contractor or consultant where there has been failure of competitive bidding;

WHEREAS, based on abovementioned guidelines, the Bids and Awards Committee of this office hereby resort to Alternative Mode of Procurement using Negotiated Procurement-Two Failed Bidding;

WHEREAS, after review of the technical specifications, terms and conditions of the contract, the BAC posted an Invitation to a Negotiated Procurement at the PhilGeps and Agency websites and invited qualified suppliers who has the legal, technical and financial capability based on records of the agency;

WHEREAS, a meeting was held last June 27, 2022 via teleconference to discuss the specifications and other technical requirements of the projects and invited them to submit proposals within the deadline;

WHEREAS, the BAC received only one (1) proposal from the invited/interested suppliers, namely; Julimons International Agri Trading Corp. which was subsequently reviewed by the BAC-TWG for its compliance to the specifications and other documentary requirements;


WHEREAS, the BAC in its deliberation on July 11, 2022 found that Julimons International Agri Trading Corp. has the single calculated bid and found to be compliant to the technical requirements upon post qualification, hence, declared as the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Engr. Ricardo M. Oñate, Jr. to award the supply and delivery of 3 units Compact Rice Mill to Julimons International Agri Trading Corp. as its bid/offer is considered the Single Calculated and Responsive Bid.
