BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF ALL WEATHER TYPE DRYER (E2)

Resolution No. 714-2022
Series of 2022

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last June 16, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of All Weather Type Dryer under HVCD Program-GAA 2022 with a total Approved Budget for the Contract (ABC) of **Three Million Four Hundred Forty-One Thousand Four Hundred Forty-Seven Pesos (P 3,441,447.00)** grouped into 3 lots;

Lot 1 – 7 units for Agusan del Sur	- Php 892,227.00
Lot 2 – 2 units for Surigao del Norte	- 254,922.00
Lot 3 – 18 units for Surigao del Sur	- 2,294,298.00

WHEREAS, an opening of bids was conducted on July 11, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there was only one (1) bidder who bought and submitted its bid for Lot1 and Lot 3, namely, Naharo Builders, Inc.;

WHEREAS, upon opening of the bids, the BAC members examined the submitted technical component of its bid to verify the presence or absence of the required documents and was rated as "Passed" and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by Naharo Builders, Inc for Lot1 and Lot 3 as the Single Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted the post qualification to Naharo Builders, Inc. having the Single Calculated Bid on Lot 1 and Lot3 to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on July 18, 2022, it was declared that Naharo Builders, Inc. had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid both for Lot 1 and Lot 3;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the supply and delivery of All Weather Type Dryer Lot 1 and Lot 3 to Naharo Builders, Inc. as its bid was considered the Single Calculated and Responsive Bid;

FURTHER RECOMMENDING, that Lot 2 composed of 2 units for Surigao del Norte be procured using Small Value Procurement, to fast tract its implementation;

RESOLVED, this 18th day of July 2022 at Butuan City, Philippines.




