BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CANAL IMPROVEMENT OF LUBCON DIVERSION DAM AT BRGY. LUBCON, CORTES, SURIGAO DEL SUR (F4)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last August 6, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Canal Improvement of Lubcon Diversion Dam at Brgy. Lubcon, Cortes, Surigao del Sur under Rice Program-GAA 2022 with a total Approved Budget for the Contract (ABC) of **One Million One Hundred Eighty Thousand Pesos (P 1,180,000.00)**;

WHEREAS, an opening of bids was conducted on August 30, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there was only one (1) bid that was rated as passed namely, GC Construction and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on September 02, 2022, the BAC determined that the bid submitted by GC Construction as a Single Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on September 6, 2022 the post qualification to GC Construction, having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on September 12, 2022, it was declared that GC Construction had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the procurement of Labor and Materials for the Canal Improvement of Lubcon Diversion Dam at Brgy. Lubcon, Cortes, Surigao del Sur to GC Construction as its bid was considered the Single Calculated and Responsive Bid;
