

## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CANAL IMPROVEMENT OF UNSAYAWON DIVERSION DAM AT BRGY. LABNIG, TALACOGON, AGUSAN DEL SUR (F6)

## Resolution No. 717-2028 Series of 2022

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last August 6, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Canal Improvement of Unsayawon Diversion Dam at Brgy. Labnig, Talacogon, Agusan del Sur under Rice Program-GAA 2022 with a total Approved Budget for the Contract (ABC) of Three Million One Hundred Twelve Thousand Six Hundred Sixty-Six Pesos (P 3,112,666.00);

WHEREAS, an opening of bids was conducted on August 30, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were three (3) bids that were rated as passed namely, (1) Jimberns Builders & Construction Supply, (2) BN Builders and Construction Supplies, Inc., and (3) GC Construction and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on September 02, 2022, the BAC determined that the bid submitted by Jimberns Builders & Construction Supply as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on September 6, 2022 the post qualification to Jimberns Builders & Construction Supply, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on September 12, 2022, it was declared that Jimberns Builders & Construction Supply had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of Labor and Materials for the Canal Improvement of Unsayawon Diversion Dam at Brgy. Labnig, Talacogon, Agusan del Sur to Jimberns Builders & Construction Supply as its bid was considered the Lowest Calculated and Responsive Bid;
