



**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF 1-UNIT WAREHOUSE (G1/F2)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last September 13, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of 1-Unit Warehouse located at Brgy. San Vicente, Prosperidad, Agusan del Sur under HVCD Program-GAA 2022 with a total Approved Budget for the Contract (ABC) of **One Million Ninety-Seven Thousand Six Pesos (P 1,097,006.00)**;

WHEREAS, an opening of bids was conducted on October 4, 2022, 9:15 A. M. at DA Lobby, 1<sup>st</sup> Building, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were three (3) bids that were rated passed namely, (1) Dave Construction General Engineering, (2) Two J.E. Construction & Supply, and (3) Naharo Builders, Inc. and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on October 5, 2022, the BAC determined that the bid submitted by Two J.E. Construction & Supply as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on October 6, 2022 the post qualification to Two J.E. Construction & Supply having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on October 6, 2022, it was declared that Two J.E. Construction & Supply had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of Labor and Materials for the Construction of 1-Unit Warehouse located at Brgy. San Vicente, Prosperidad, Agusan del Sur as its bid was considered the Lowest Calculated and Responsive Bid;
