**BAC RESOLUTION DECLARING FAILURE OF BIDS FOR THE PROCUREMENT OF VARIOUS FERTILIZER (C11) AND RECOMMENDING TO RESORT TO NEGOTIATED PROCUREMENT DUE TO 2-FAILED BIDS**

**Resolution No. 227-2022  
Series of 2022**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 25, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the second time the Procurement of Various Fertilizers under the Corn Program-GAA 2022 with a total Approved Budget for the Contract (ABC) of **Five Million Eight Hundred Forty-Nine Thousand Seven Hundred Thirty Pesos (P 5,849,730.00)** grouped into 2 lots:

Lot 1 – 1,856 bags Complete Fertilizer (14-14-14), 13 bags Solophosphate (0-18-0),  
and 995 bags Muriate of Potash (0-0-60) -P 5,722,800.00

Lot 2 – 45 bags Calcium Nitrate, 43 bottles Liquid Calcium Boron, and  
19 bottles Paclobutrazole, - 126,930.00

WHEREAS, a pre-bid conference was held virtually through <https://meet.google.com/yih-ztes-gtx> last April 4, 2022, as scheduled;

WHEREAS, an opening of bids was conducted on April 19, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were no bids received for the said project;

WHEREAS, pursuant to Section 35.1(b) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184), the Bids and Awards Committee shall declare a failure of bidding when no bids are received, among others;

NOW THEREFORE, the BAC recommends to the Head of Procuring Entity, Regional Executive Director, Engr. Ricardo M. Onate, Jr. to declare failure of bidding for the Procurement of Various Fertilizers both for Lot1 and Lot2;

RECOMMENDING FURTHER, that a Negotiated Procurement will be employed to fast tract the implementation of this project considering that there are already two (2) Failed Biddings declared;
