CONTRACT AGREEMENT

THIS AGREEMENT made the _____ day of ______ 2023 between **Department** of Agriculture-Caraga Region of the Philippines hereinafter called "the Entity" of the one part and Hiron's General Merchandise of Madrid, Surigao del Sur Philippines hereinafter called "the Supplier" of the other part;

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed. Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of *Three Million Five Hundred Twenty-Eight Thousand Pesos Only (P 3,528,000.00)* or such other sums as may be ascertained, *Hiron's General Merchandise* agrees to the *Procurement of 1,680 bags Layer Mash* in accordance with his/her/its Bid.
- 4. The **Department of Agriculture-Caraga Region** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
