CONTRACT AGREEMENT

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In consideration for the sum of Four Hundred Thirty-Three Thousand Two Hundred Five Pesos & 77/100 Only (P 433,205.77) or such other sums as may be ascertained, AC Dupa Construction Services agrees to the Construction of FBD (Roofing & Concrete Flooring) at Brgy. Hawilian, Esperanza, Agusan del Sur (Lot 1) in accordance with his/her/its Bid.
- 4. The **Department** of **Agriculture-Caraga Region** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
