CONTRACT AGREEMENT

THIS AGREEMENT made the 16th day of May 2023 between Department of Agriculture-Caraga Region of the Philippines hereinafter called "the Entity" of the one part and Right Agri Development, Inc. of Ramon, Isabela, Philippines hereinafter called "the Supplier" of the other part;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of *Eight Million Four Hundred Sixty-Six Thousand Pesos Only (P 8,466,000.00)* or such other sums as may be ascertained, *Right Agri Development, Inc.* agrees to the *Procurement of 1,660 bags Hybrid Rice Seeds (M116) Lot 4* in accordance with his/her/its Bid.
- 4. The *Department of Agriculture-Caraga Region* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
