- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of *One Million Two Hundred Seventy-Four Thousand Seven Hundred Fifty-Six Pesos Only (P 1,274,756.00)* or such other sums as may be ascertained, *First Planters Agri Solution, Inc.* agrees to the *Procurement of Various Inorganic Fertilizers (Lots 2 & 3)* in accordance with his/her/its Bid.
- 4. The **Department of Agriculture-Caraga Region** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
