



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 5,000 LITERS ORGANIC FOLIAR FERTILIZER (A46)

**Resolution No. 029-2023
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 5,000 Liters Organic Foliar Fertilizer - Short of Award under Rice Program-NEP 2023 with a total Approved Budget for the Contract (ABC) of **Three Million Five Hundred Thousand Pesos (P 3,500,000.00)**;

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were three (3) bids received from (1) Enviro Scope Synergy Inc., (2) Phoenix Larrel Agriventures and (3) Aktiv Multi Trading Co. Phils, Inc., all were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 13, 2022, the BAC determined that the bid submitted by Enviro Scope Synergy Inc. as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on December 27, 2022 the post qualification to Mars Agri Ventures and Commodities Inc. having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 12, 2023, it was declared that Enviro Scope Synergy Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;


