



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF SECURITY SERVICES (A1)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Security Services – Short of Award under GASS-NEP 2023 with a total Approved Budget for the Contract (ABC) of **Five Million Sixteen Thousand Pesos (P 5,016,000.00)**;

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bids received from Visa Security Services and Axzeen Security Agency, all were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on January 12, 2023, the BAC determined that the bid submitted by Axzeen Security Agency as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 18, 2023 the post qualification of Axzeen Security Agency to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 23, 2023, it was agreed that the BAC had to determine the performance of Axzeen Security Agency from their previous and current clients;

WHEREAS, the BAC upon its final deliberation on January 26, 2023, found that Axzeen Security Agency was rated as very satisfactory from two (2) clients and outstanding performance rating with the other client, hence, the BAC declared that Axzeen Security Agency had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;



RESOLVED, this 26th day of January 2023 at Butuan City, Philippines.


