



**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 25,000
PIECES BANANA PLANTING MATERIALS (A13)**

**Resolution No. 026-2023
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 25,000 pieces Banana Planting Materials – Short of Award under SAAD Program-NEP 2023 with a total Approved Budget for the Contract (ABC) of **One Million Pesos (P1,000,000.00)**;

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were five (5) bids received, namely, (1)Tierra Organia Corporation, (2)JC Mejos Agri Ventures, (3)Two A & K Agricultural Nursery, (4)Aktiv Multi Trading Co Phils, Inc. and (5)St. Padre Pio’s Garden, which were all rated as Passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation, the BAC determined that the bid submitted by St. Padre Pio’s Garden as the Lowest Calculated Bid and subject for post qualification, however, it did not pass the post qualification because of no BPI-accredited laboratory;

WHEREAS, the BAC had evaluated the next lowest bids of Aktiv Multi Trading Co Phils, Inc. Two A & K Agricultural Nursery and Tierra Organia Corporation, but all of them did not pass the detailed evaluation due to non- compliance of a BPI-accredited laboratory;

WHEREAS, upon evaluation of the bid of JC Mejos Agri Ventures, the BAC found that it was compliant to all of the technical requirements especially on a BPI-accredited laboratory, hence was considered for post qualification;

WHEREAS, the BAC together with the TWG conducted on February 14, 2023 the post qualification of JC Mejos Agri Ventures to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on February 21, 2023, it was declared that the bid of JC Mejos Agri Ventures was the Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the procurement of 25,000 pieces Banana Planting Materials to JC Mejos Agri Ventures as its bid was considered the Lowest Calculated and Responsive Bid;
