

BAC RESOLUTION RECOMMENDING AWARD FOR THE CONSTRUCTION OF THE 2-STOREY ORGANIC HUB BUILDING AT BRGY. POBLACION, SIBAGAT, AGUSAN DEL SUR (B9)

Resolution No. 051-2023 Series of 2023

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 11, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Construction of the 2-Storey Organic Hub Building at Brgy. Poblacion, Sibagat, Agusan del Sur under OA Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of Four Million Pesos (P 4,000,000.00);

WHEREAS, an opening of bids was conducted on April 3, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were eight (8) bids received, ML_Builders Inc. and Stef Construction were rated as "failed". DRDF Construction and Supply, J-R3 Construction and Supply, Ilmar Construction & Supply, AA Construction, Poliran Builders Corporation and BN Builders and Construction Supplies Inc., were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 11, 2023, the BAC determined that the bid submitted by DRDF Construction and Supply as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on April 17, 2023 the post qualification to DRDF Construction and Supply, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on April 25, 2023, it was declared that DRDF Construction and Supply, had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Construction of the 2-Storey Organic Hub Building at Brgy. Poblacion, Sibagat, Agusan del Sur to DRDF Construction and Supply, as its bid was considered the Lowest Calculated and Responsive Bid;
