**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 424 BAGS
CONTROLLED RELEASE FERTILIZER (C3)**

**Resolution No. 067-2023
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last June 1, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 424 bags Controlled Release Fertilizer under CFID Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **Two Million Seven Hundred Fifty-Six Thousand Pesos (P2,756,000.00)**;

WHEREAS, an opening of bids was conducted on June 21, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from Ramgo International Corporation received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on June 26, 2023, the BAC determined that the bid submitted by Ramgo International Corporation as the Single Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on July 5, 2023 the post qualification to Ramgo International Corporation having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on July 10, 2023, it was declared that Ramgo International Corporation had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of 424 bags Controlled Release Fertilizer* to Ramgo International Corporation as its bid was considered the Single Calculated and Responsive Bid;
