BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF 2 UNITS AGRICULTURAL GREENHOUSE WITH NURSERY (C4)

**Resolution No. 068-2023
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last June 1, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of 2 units Agricultural Greenhouse with Nursery under NUPA Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **One Million Seventy-Six Thousand Pesos (P1,076,000.00)** which was grouped into two (2) lots;

- Lot 1: 1 unit Agricultural Greenhouse with Nursery -Php538,000.00
at Rosario, Agusan del Sur
- Lot 2: 1 unit Agricultural Greenhouse with Nursery -Php538,000.00
at Butuan City

WHEREAS, an opening of bids was conducted on June 21, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there was only one (1) bid from L.E.S. Construction received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, during the opening of bid, it was noted that the bid submitted by L.E.S. Construction is only for Lot 2, and there was no bid received for Lot 1;

WHEREAS, upon deliberation of the detailed bid evaluation on June 26, 2023, the BAC determined that the bid submitted by L.E.S. Construction for Lot 2 as the Single Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on July 4, 2023 the post qualification to L.E.S. Construction having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on July 10, 2023, it was declared that L.E.S. Construction had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of Lot 2-1 unit Agricultural Greenhouse with Nursery at Butuan City* to L.E.S. Construction as its bid was considered the Single Calculated and Responsive Bid;


