



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS AGRICULTURAL INPUTS AND TOOLS (A19)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Agricultural Inputs and Tools – Short of Award under HVCD Program-NEP 2023 with a total Approved Budget for the Contract (ABC) of **Four Million Two Hundred Forty-Four Thousand Two Hundred Ten Pesos (P 4,244,210.00)**;

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were two (2) bids received from J777 Agri Marketing Corp and Jeel's Masagana Farm Supply, both were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 13, 2022, the BAC determined that the bid submitted by Jeel's Masagana Farm Supply as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on December 20, 2022 the post qualification to Jeel's Masagana Farm Supply having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;


WHEREAS, upon final deliberation conducted by the BAC members on January 12, 2023, it was declared that Jeel's Masagana Farm Supply had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;




