## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 55 HEADS GOAT (A26)

Resolution No. 014-2023  
Series of 2023

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 55 heads Goat – Short of Award under Livestock Program-NEP 2023 with a total Approved Budget for the Contract (ABC) of **One Million Four Hundred Ninety-Nine Thousand Nine Hundred Eighty-One Pesos (P 1,499,981.00)** grouped into four (4) lots;

Lot 1 – 14 heads Goat: Anglo Nubian	- Php381,815.00
Lot 2 – 14 heads Goat: Boer	- Php381,815.00
Lot 3 – 14 heads Goat: Saanen	- Php381,815.00
Lot 4 – 13 heads Goat: Upgraded	- Php354,536.00

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were four (4) bids received from Julimon International Agri Trading Corp, BMA Livestock Dealer, Sagana Farm and Tommy's Hogs and Cattle, all were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 13, 2022, the BAC determined that the bid submitted by Tommy's Hogs and Cattle for Lot 1, Julimon International Agri Trading Corp. for Lot 2, and Sagana Farm for Lot 4 as the Lowest Calculated Bid and Julimon International Agri Trading Corp. for Lot 3 as a Single Calculated Bid, all were subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on December 21, 2022 the post qualification of Sagana Farm and Tommy's Hogs and Cattle, Julimon International Agri Trading Corp on December 27, 2022 to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 12, 2023, it was declared that Sagana Farm, Tommy's Hogs and Cattle and Julimon International Agri Trading Corp had passed the post qualification requirements and were considered the Lowest/Single Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the procurement of Lot 1 – 14 heads Goat: Anglo Nubian to Tommy's Hogs and Cattle, Lot 2 – 14 heads Goat: Boer to Julimon International Agri Trading Corp and Lot 4 – 13 heads Goat: Upgraded to Sagana Farm as its bid were considered the Lowest Calculated and Responsive Bid while Lot 3 – 14 heads Goat: Saanen to Julimon International Agri Trading Corp as its bid was considered the Single Calculated and Responsive Bid;


