



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF SWINE FEEDS (A27)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Swine Feeds – Short of Award under Livestock Program-NEP 2023 with a total Approved Budget for the Contract (ABC) of **Two Million One Hundred Sixty Thousand Pesos (P 2,160,000.00)** grouped into two (2) lots;

<i>Lot 1 – 540 bags Hog Grower Pellets</i>	<i>- Php1,080,000.00</i>
<i>Lot 2 – 540 bags Hog Starter Pellets</i>	<i>- Php1,080,000.00</i>

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there was one (1) bid from Hiron's General Merchandise received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 13, 2022, the BAC determined that the bid submitted by Hiron's General Merchandise as the Single Calculated Bid for Lot 1 and Lot 2 and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on December 27, 2022 the post qualification to Hiron's General Merchandise having declared the Single Calculated Bid for Lot 1 and Lot 2 to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 12, 2023, it was declared that Hiron's General Merchandise had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid for Lot 1 and Lot 2;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of Swine Feeds to Hiron's General Merchandise as its bid was considered the Single Calculated and Responsive Bid for Lot1 and Lot 2;
