



**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CANAL IMPROVEMENT OF CAMAM-ONAN DIVERSION DAM AT BRGY. BURGOS, CORTES, SURIGAO DEL SUR (A40)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Canal Improvement of Camam-onan Diversion Dam at Brgy. Burgos, Cortes, Surigao del Sur – Short of Award under Rice Program-NEP 2023 with a total Approved Budget for the Contract (ABC) of **One Million Five Hundred Six Thousand Pesos (P 1,506,000.00)**;

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were two (2) bids received from GC Construction and C & R Construction & Supply, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 12, 2022, the BAC determined that the bid submitted by GC Construction, as the Lowest Calculated Bid and was subjected to post qualification;


WHEREAS, the BAC together with the TWG conducted on December 27, 2022 the post qualification to GC Construction having declared as the Lowest Calculated Bid to determine its capability to supply the contract if awarded;


WHEREAS, upon final deliberation conducted by the BAC members on January 11, 2023, it was declared that GC Construction had passed the post qualification requirements and was considered as Lowest Calculated and Responsive Bid;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of Labor and Materials for the Canal Improvement of Camam-onan Diversion Dam at Brgy. Burgos, Cortes, Surigao del Sur to GC Construction as its bid was considered the Lowest Calculated and Responsive Bid;
