



**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 1,500 KGS.
RODENTICIDES (ACUTE) (A45)**

**Resolution No. 028-2023
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 1,500 kgs. Rodenticide (Acute) – Short of Award under Rice Program-NEP 2023 with a total Approved Budget for the Contract (ABC) of **Two Million Seven Hundred Thousand Pesos (P 2,700,000.00)**;

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were four (4) bids received from Aktiv Multi Trading Co. Phils, Inc, Enviro Scope Synergy Inc., Jeel's Masagana Farm Supply, Inc. and Mars Agri Ventures and Commodities Inc., all were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 13, 2022, the BAC determined that the bid submitted by Mars Agri Ventures and Commodities Inc. as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on December 21, 2022 the post qualification to Mars Agri Ventures and Commodities Inc. having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 12, 2023, it was declared that Mars Agri Ventures and Commodities Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 1,500 kgs. Rodenticide (Acute) to Mars Agri Ventures and Commodities Inc. as its bid was considered the Lowest Calculated and Responsive Bid;
