



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE REHABILITATION OF MAHABO DIVERSION DAM AT BRGY. PONGTOD, SAN AGUSTIN, SURIGAO DEL SUR (A37)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Rehabilitation of Mahabo Diversion Dam at Brgy. Pongtod, San Agustin, Surigao del Sur – Short of Award under Rice Program-NEP 2023 with a total Approved Budget for the Contract (ABC) of **One Million Nine Hundred Sixty Thousand Pesos (₱ 1,960,000.00)**;

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there was only one (1) bid from C & R Construction & Supply received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 12, 2022, the BAC determined that the bid submitted by C & R Construction & Supply as the Single Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on January 25, 2023 the post qualification to C & R Construction & Supply having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 26, 2023, it was declared that C & R Construction & Supply had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;


