## BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 4 UNITS HAULING VEHICLE (A7)

Resolution No. 037-2023  
Series of 2023

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 4 units Hauling Vehicle – Short of Award under Corn Program-NEP 2023 with a total Approved Budget for the Contract (ABC) of **Eleven Million Pesos (P 11,000,000.00)** grouped into two (2) lots;

Lot 1 – 3 units Hauling Vehicle (16ft)	- Php9,000,000.00
Lot 2 – 1 unit Hauling Vehicle (10ft)	- Php2,000,000.00

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid received from Image Motors Davao del Norte, Inc., rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 12, 2022, the BAC determined that the bid submitted by Image Motors Davao del Norte, Inc. as the Single Calculated Bid for Lot 1 and Lot 2 and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on December 22, 2022 the post qualification to Image Motors Davao del Norte, Inc having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 11, 2023, it was declared that Image Motors Davao del Norte, Inc had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid both for Lot1 and Lot2;


NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of Lot 1 – 3 units Hauling Vehicle (16ft) and Lot 2 – 1 unit Hauling Vehicle (10ft) to Image Motors Davao del Norte, Inc. as its bid was considered the Single Calculated and Responsive Bid;
