BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 2 UNITS FARM TRACTOR (HVCDP) (A22)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 2 units Farm Tractor (HVCDP) – Short of Award under HVCD Program-NEP 2023 with a total Approved Budget for the Contract (ABC) of **Three Million Pesos (₱ 3,000,000.00)**;

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there were three (3) bids received from Ford Tractor Philippines, Agri Component Corporation and Fortunetract Agro-Sales, Inc., rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 12, 2022, the BAC determined that the bid submitted by Fortunetract Agro-Sales, Inc. as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on December 23, 2022 the post qualification to Fortunetract Agro-Sales, Inc. having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 11, 2023, it was declared that Fortunetract Agro-Sales, Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 2 units Farm Tractor to Fortunetract Agro-Sales, Inc. as its bid was considered the Lowest Calculated and Responsive Bid;
