



**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 1 UNIT  
HAULING VEHICLE FOR LIVESTOCK – SHORT OF AWARD (A28)**

**Resolution No. 041-2023

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last November 4, 2022 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 1 unit Hauling Vehicle for Livestock – Short of Award under Livestock Program-NEP 2023 with a total Approved Budget for the Contract (ABC) of **One Million Five Hundred Thousand Pesos (₱ 1,500,000.00)**;

WHEREAS, an opening of bids was conducted on November 24, 2022, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid received from Globalcars, Inc. rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on December 12, 2022, the BAC determined that the bid submitted by Globalcars, Inc. as the Single Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on December 20, 2022 the post qualification to Globalcars, Inc. Inc. having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on January 11, 2023, it was declared that Globalcars, Inc. had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 1 unit Hauling Vehicle to Globalcars, Inc. as its bid was considered the Single Calculated and Responsive Bid;
