**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 12,794
PACKS BIO-N FERTILIZER (CORN) (B3)**

**Resolution No. 046-2023
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 11, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 12,794 packs Bio-N fertilizer (Corn) under Corn Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **One Million Two Hundred Fifty-Three Thousand Eight Hundred Twelve Pesos (₱1,253,812.00)**;

WHEREAS, an opening of bids was conducted on April 3, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bids received from Green Asia Agri Ventures, Inc. and JCV Worldwide Traders Corporation, both were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 11, 2023, the BAC determined that the bid submitted by Green Asia Agri Ventures, Inc. as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on April 20, 2023 the post qualification to Green Asia Agri Ventures, Inc., having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;


WHEREAS, upon final deliberation conducted by the BAC members on April 25, 2023, it was declared that Green Asia Agri Ventures, Inc., had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 12,794 packs Bio-N fertilizer (Corn) to Green Asia Agri Ventures, Inc., as its bid was considered the Lowest Calculated and Responsive Bid;


