**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 540 HEADS
PIGLETS (B4)
Resolution No. 047-2023
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 11, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 540 Heads Piglets under Livestock Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **Five Million Two Hundred Ninety-Two Thousand Pesos (P5,292,000.00)** grouped into three (3) lots;

Lot 1 - 180 heads of Piglets for delivery to Agusan del Sur (Trento, Sta. Josfea, La Paz)	-Php1,764,000.00
Lot 2 - 240 heads Piglets for delivery to Suriao del Sur (Bayabas, Bislig City, San Agustin, Tagbina, Tandag City, Tago)	-Php2,352,000.00
Lot 3 - 120 heads Piglets for delivery to Surigao del Norte & Agusan del Norte (San Francisco, Malimono, Mainit, Surigao City and Cabadbaran City, Agusan del Norte)	-Php1,176,000.00

WHEREAS, an opening of bids was conducted on April 3, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bids received from Pere-Green Agri Resources, Happy Enterprises & Resources Incorporated and Julimon International Trading Corp., all bids were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 11, 2023, the BAC determined that the bid submitted by Julimon International Trading Corp. as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on April 19, 2023 the post qualification to Julimon International Trading Corp., having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on April 25, 2023, it was declared that Julimon International Trading Corp., had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 540 heads piglets to Julimon International Trading Corp., as its bid was considered the Lowest Calculated and Responsive Bid for Lots 1, 2 and 3;
