**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 1 UNIT FEED PELLETIZING MACHINE (3 IN 1) (B8)**

**Resolution No. 050-2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 11, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 1-unit Feed Pelletizing Machine (3 in 1) under OA Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **One Million Six Hundred Fifty-Two Thousand Two Hundred Pesos (₱ 1,652,200.00)**;

WHEREAS, an opening of bids was conducted on April 3, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from Davao Techno Craft received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 11, 2023, the BAC determined that the bid submitted by Davao Techno Craft as the Single Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on April 18, 2023 the post qualification to Davao Techno Craft having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on April 25, 2023, it was declared that Davao Techno Craft, had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 1-unit Feed Pelletizing Machine (3 in 1) to Davao Techno Craft, as its bid was considered the Single Calculated and Responsive Bid;

RESOLVED, this 25<sup>th</sup> day of April 2023 at Butuan City, Philippines.


