**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 45,000 PIECES  
ABACA PLANTING MATERIALS (SUCKERS) (B10/A12)**

**Resolution No. 052 - 2023  
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 11, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 45,000 pieces Abaca Planting Materials (Suckers) under SAAD Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **One Million Eight Hundred Thousand Pesos (₱ 1,800,000.00)**;

WHEREAS, an opening of bids was conducted on April 3, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were three (3) bids received from Bebot Rubber Nursery, Renel's Fruit Nursery and Ernie Agroforest Nursery, all were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 11, 2023, the BAC determined that the bid submitted by Ernie Agroforest Nursery as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on April 14, 2023 the post qualification to Ernie Agroforest Nursery having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on May 12, 2023, it was declared that Ernie Agroforest Nursery had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 45,000 pieces Abaca Planting Materials (Suckers) to Ernie Agroforest Nursery as its bid was considered the Lowest Calculated and Responsive Bid;
