BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 14,000 PIECES CALAMANSI PLANTING MATERIALS (B13)

**Resolution No. 055-1023
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last March 11, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 14,000 pieces Calamansi Planting Materials under HVCD Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **One Million Two Hundred Sixty Thousand Pesos (P 1,260,000.00)**;

WHEREAS, an opening of bids was conducted on April 3, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were four (4) bids received from St. Padre Pio's Garden, Paman Plant Nursery, Binahon Agroforestry Farm and Renel's Fruit Nursery, all were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 11, 2023, the BAC determined that the bid submitted by Binahon Agroforestry Farm as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on April 19, 2023 the post qualification to Binahon Agroforestry Farm, having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on April 25, 2023, it was declared that Binahon Agroforestry Farm, had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 14,000 pieces Calamansi Planting Materials to Binahon Agroforestry Farm, as its bid was considered the Lowest Calculated and Responsive Bid;
