



**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF VARIOUS  
HYBRID RICE SEEDS (B18)**

**Resolution No. 059-2023  
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last March 11, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Various Hybrid Rice Seeds under Rice Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **Seventy-Six Million Six Hundred Twenty-Seven Thousand Five Hundred Pesos (P76,627,500.00)** grouped into seven (7) lots;

Lot 1 – 6,400 bags Hybrid Rice Seeds (M78)	-Php32,640,000.00
Lot 2 – 2,700 bags Hybrid Rice Seeds (M81)	-Php13,770,000.00
Lot 3 – 1,650 bags Hybrid Rice Seeds (M46)	-Php 8,415,000.00
Lot 4 – 1,660 bags Hybrid Rice Seeds (M116)	-Php 8,466,000.00
Lot 5 – 400 bags Hybrid Rice Seeds (M82)	-Php 2,040,000.00
Lot 6 – 1,615 bags Hybrid Rice Seeds (M28)	-Php 8,236,500.00
Lot 7 – 600 bags Hybrid Rice Seeds (M92)	-Php 3,060,000.00

WHEREAS, an opening of bids was conducted on April 3, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were six (6) bids received from Longping Tropical Rice Development, Inc. OJM Seed Producer and Agricultural Services, Right Agri Development Incorporated, SL Agritech Corporation, Jedeco Trading Corporation and Ramgo International Corporation, all bids were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on April 11, 2023, the BAC determined that the bid submitted by Longping Tropical Rice Development, Inc for Lot 1; OJM Seed Producer and Agricultural Services for Lot 6; Right Agri Development Incorporated for Lot 4; SL Agritech Corporation for Lot 2; Jedeco Trading Corporation for Lots 3 and 5; and Ramgo International Corporation for Lot 7, as the Single Calculated Bid and were all subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on April 17, 2023 the post qualification to all the above-mentioned bidders to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on April 25, 2023, it was declared that Longping Tropical Rice Development, Inc for Lot 1; OJM Seed Producer and Agricultural Services for Lot 6; Right Agri Development Incorporated for Lot 4; SL Agritech Corporation for Lot 2; Jedeco Trading Corporation for Lots 3 and 5; and Ramgo International Corporation for Lot 7, had all passed the post qualification requirements;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the procurement of Lot 1 - 6,400 bags Hybrid Rice Seeds (M78) to Longping Tropical Rice Development, Inc; Lot 2 - 2,700 bags Hybrid Rice Seeds (M81) to SL Agritech Corporation; Lot 3 - 1,650 bags Hybrid Rice Seeds (M46) and Lot 5 - 400 bags Hybrid Rice Seeds (M82) to Jedeco Trading Corporation; Lot 6 - 1,615 bags Hybrid Rice Seeds (M28) to OJM Seed Producer and Agricultural Services; and Lot 7 - 600 bags Hybrid Rice Seeds (M92) to Ramgo International Corporation, as its bid were considered the Single Calculated and Responsive Bid;
