**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 1 UNIT  
COMPOST TURNER (E1)**

**Resolution No. 073 - 2023  
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last September 7, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 1-unit Compost Turner under OA Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **Four Million One Hundred Thousand Pesos (P4,100,000.00)**;

WHEREAS, an opening of bids was conducted on September 28, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, and there was only one (1) bid from RU Foundry & Machine Shop Corporation received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on October 3, 2023, the BAC determined that the bid submitted by RU Foundry & Machine Shop Corporation as the Single Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on October 5, 2023 the post qualification to RU Foundry & Machine Shop Corporation having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;


WHEREAS, upon final deliberation conducted by the BAC members on October 10, 2023, it was declared that RU Foundry & Machine Shop Corporation had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of 1-unit Compost Turner* to RU Foundry & Machine Shop Corporation as its bid was considered the Single Calculated and Responsive Bid;


