BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 200 BAGS HYBRID CORN SEEDS (E3)

**Resolution No. 073-2023
 Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last September 7, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 200 bags Hybrid Corn Seeds under Corn Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **One Million Two Hundred Thousand Pesos (₱1,200,000.00)**;

WHEREAS, an opening of bids was conducted on September 28, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from Aktiv Multi Trading Co. Phils., Inc. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on October 3, 2023, the BAC determined that the bid submitted by Aktiv Multi Trading Co. Phils., Inc. as the Single Calculated Bid and was subjected to post qualification;


WHEREAS, the BAC together with the TWG conducted on October 5, 2023 the post qualification to Aktiv Multi Trading Co. Phils., Inc. having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on October 10, 2023, it was declared that Aktiv Multi Trading Co. Phils., Inc. had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of 200 bags Hybrid Corn Seeds* to Aktiv Multi Trading Co. Phils., Inc. as its bid was considered the Single Calculated and Responsive Bid;

RESOLVED, this 10th day of October 2023 at Butuan City, Philippines.


