



BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE ESTABLISHMENT OF 1 UNIT FLATBED DRYER (ROOFING AND CONCRETE FLOORING) AT BRGY. HAWILIAN, ESPERANZA, AGUSAN DEL SUR (E4)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last September 7, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Establishment of 1-unit Flatbed Dryer (Roofing and Concrete Flooring) at Brgy. Hawilian, Esperanza, Agusan del Sur under Corn Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **Four Hundred Ninety-Eight Thousand Pesos (P498,000.00)**;

WHEREAS, an opening of bids was conducted on September 28, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bids from AC Dupa Construction Services and RMB Development Corporation received, and only the bid submitted by AC Dupa Construction Services was rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on October 3, 2023, the BAC determined that the bid submitted by AC Dupa Construction Services as the Single Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on October 4, 2023 the post qualification to AC Dupa Construction Services having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on October 10, 2023, it was declared that AC Dupa Construction Services had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of Labor and Materials for the Establishment of 1-unit Flatbed Dryer (Roofing and Concrete Flooring) at Brgy. Hawilian, Esperanza, Agusan del Sur* to AC Dupa Construction Services as its bid was considered the Single Calculated and Responsive Bid;
