BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF 1 UNIT WAREHOUSE AT SISON, SURIGAO DEL NORTE (E6)

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last September 7, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of Labor and Materials for the Construction of 1 unit Warehouse at Sison, Surigao del Norte under Rice Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **Two Million Three Hundred Twenty-Two Thousand Six Hundred Ninety-Six Pesos (P2,322,696.00)**;

WHEREAS, an opening of bids was conducted on September 28, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were eight (8) bids received from RMB Development Corporation, C&R Construction & Supply, Stef Construction, Point72 Engineering Services, BN Builders & Construction Supply, Inc., Zeart Construction Supply Co., RKBoy Construction Services and DMAN Construction and Supply, and only the bids submitted by C&R Construction & Supply, Stef Construction, Point72 Engineering Services, BN Builders & Construction Supply, Inc., Zeart Construction Supply Co., and RKBoy Construction Services were rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on October 3, 2023, the BAC determined that the bid submitted by Zeart Construction Supply Co. was non-complying due to the Bill of Quantities (BOQ) was not signed and sealed by an Agricultural and Biosystems Engineer hence, declared non-responsive;

WHEREAS, during the deliberation of the detailed bid evaluation, the BAC further determined that the bid submitted by C&R Construction & Supply as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on October 4, 2023 the post qualification to C&R Construction & Supply having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;


WHEREAS, upon final deliberation conducted by the BAC members on October 10, 2023, it was declared that C&R Construction & Supply had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of Labor and Materials for the Construction of 1-unit Warehouse at Sison, Surigao del Norte* to C&R Construction & Supply as its bid was considered the Lowest Calculated and Responsive Bid;


