**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF  
PROCUREMENT OF 1 UNIT FARM TRACTOR (C5)**

**Resolution No. 079-2023  
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last June 1, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 1 unit Farm Tractor under the Corn Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **Two Million Four Hundred Ten Thousand Pesos (₱ 2,410,000.00)**;

WHEREAS, an opening of bids was conducted on June 21, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there was only one (1) bid from Ford Tractor Philippines, Inc. received, rated as passed and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on June 26, 2023, the BAC determined that the bid submitted by Ford Tractor Philippines, Inc. as the Single Calculated Bid and was subjected to post qualification;


WHEREAS, the BAC together with the TWG conducted on July 5, 2023 the post qualification to Ford Tractor Philippines, Inc. having declared the Single Calculated Bid to determine its capability to supply the contract if awarded;


WHEREAS, upon final deliberation conducted by the BAC members, it was declared that Ford Tractor Philippines, Inc. had passed the post qualification requirements and was considered the Single Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 1 unit Farm Tractor to Ford Tractor Philippines, Inc. as its bid was considered the Single Calculated and Responsive Bid;


