**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF
PROCUREMENT OF 2 UNITS HAULING VEHICLE (C6)**

**Resolution No. 090-2023
Series of 2023**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites www.da.caraga.gov.ph and www.philgeps.net last June 1, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 2 units Hauling Vehicle under Corn Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **Four Million Fifty Thousand Pesos (P4,050,000.00)** which was grouped into two (2) lots;

Lot 1: 1 unit Hauling Vehicle (16ft) - Php2,700,000.00
Lot 2: 1 unit Hauling Vehicle (10ft) - Php1,350,000.00

WHEREAS, an opening of bids was conducted on June 21, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bidders who submitted its bid and were rated as "Passed", namely, Superior Motor Corporation and Image Motors Davao del Norte, Inc. and subsequently subjected to a detailed bid evaluation;

WHEREAS, upon deliberation of the detailed bid evaluation on June 26, 2023, the BAC determined that the bid submitted by Image Motors Davao del Norte, Inc. as the Lowest Calculated Bid and was subjected to post qualification;

WHEREAS, the BAC together with the TWG conducted on July 5, 2023 the post qualification to Image Motors Davao del Norte, Inc. to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members, it was declared that Image Motors Davao del Norte, Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the Procurement of 2 units Hauling Vehicle for Lots 1 & 2 to Image Motors Davao del Norte, Inc. as its bid was considered the Lowest Calculated and Responsive Bid;

RESOLVED, this 10th day of July 2023 at Butuan City, Philippines.


