**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROCUREMENT OF 1 UNIT HAULING VEHICLE (F1/E2)**

WHEREAS, the Department of Agriculture Caraga Region had published an Invitation to Bid in the websites [www.da.caraga.gov.ph](http://www.da.caraga.gov.ph) and [www.philgeps.net](http://www.philgeps.net) last September 30, 2023 and posted on the Bulletin Board of this office continuously for 7 calendar days for the Procurement of 1-unit Hauling Vehicle under OA Program-GAA 2023 with a total Approved Budget for the Contract (ABC) of **One Million Five Hundred Thousand Pesos (P1,500,000.00)**;

WHEREAS, an opening of bids was conducted on October 23, 2023, 9:15 A. M. at the DA Conference Hall, Department of Agriculture Caraga Region, Capitol Site, Butuan City as scheduled, there were two (2) bidders who bought and submitted its bid, namely, Angcore Motor Company Inc. and Globalcars, Inc.;

WHEREAS, upon deliberation of the detailed bid evaluation on October 24, 2023, the BAC determined that the bid submitted by Globalcars, Inc. as the Lowest Calculated Bid and subject for post qualification;

WHEREAS, the BAC together with the TWG conducted on October 25, 2023 the post qualification to Globalcars, Inc. having declared the Lowest Calculated Bid to determine its capability to supply the contract if awarded;

WHEREAS, upon final deliberation conducted by the BAC members on November 16, 2023, it was declared that Globalcars, Inc. had passed the post qualification requirements and was considered the Lowest Calculated and Responsive Bid;

NOW THEREFORE, in order to promote economy and efficiency, the BAC recommends to the Head of Procuring Entity, Ricardo M. Oñate Jr., to award the *Procurement of 1-unit Hauling Vehicle* to Globalcars, Inc. as its bid was considered the Lowest Calculated and Responsive Bid;

RESOLVED, this 16<sup>th</sup> day of November 2023 at Butuan City, Philippines.


