CONTRACT AGREEMENT

 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of *One Million Six Hundred Seventy-Eight Thousand Pesos Only (P 1,678,000.00)* or such other sums as may be ascertained *Balanghai Hotel and Convention Center Corporation* agrees to the *Procurement of Meals with Venue and Accommodation for the Conduct of National Rice Program Meeting and Consultation Workshop on Rice Industry Development Program CY 2024 on November 18-22, 2024 in Butuan City* in accordance with his/her/its Bid.
