

CONTRACT AGREEMENT


THIS AGREEMENT made the **13th day of December 2024** between **Department of Agriculture-Caraga Region** of the Philippines hereinafter called "the Entity" of the one part and **Jodel Construction Supply and Merchandise of Butuan City**, Philippines hereinafter called "the Contractor".

WHEREAS, the Entity is desirous that the Contractor execute **Procurement of Labor and Materials for the Upgrading and Expansion of Feed Formulation and Storage Facility at Trento Research and Experiment Station, Caraga Region** and the entity has accepted the Bid for **One Million Five Hundred Thirty-Eight Thousand Seven Hundred Ninety-One Pesos and 66/100 Only (P 1,538,791.66)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Drawing/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Performance Security;
 - d. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **One Million Five Hundred Thirty-Eight Thousand Seven Hundred Ninety-One Pesos and 66/100 Only (P 1,538,791.66)** or such other sums as may be ascertained, **Jodel Construction Supply and Merchandise** agrees to **Procurement of Labor and Materials for the Upgrading and Expansion of Feed Formulation and Storage Facility at Trento Research and Experiment Station, Caraga Region** in accordance with his/her/its Bid.
4. The **Department of Agriculture-Caraga Region** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
