CONTRACT AGREEMENT

THIS AGREEMENT made the 19th day of December 2024 between Department of Agriculture-Caraga Region of the Philippines hereinafter called "the Entity" of the one part and Metro Coolaire Trading Corporation of Cagayan de Oro City, Philippines hereinafter called "the Supplier" of the other part;

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of One Million Sixty-Four Thousand Three Hundred Fourteen Pesos and 27/100 Only (P1,064,314.27) or such other sums as may be ascertained, Metro Coolaire Trading Corporation agrees to Procurement of Various Office Equipment in accordance with his/her/its Bid.
- The Department of Agriculture-Caraga Region agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
